# Information on Processing of Personal Data pursuant to Art. 13 of GDPR

Dear delegates, via this document in accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation, hereinafter the "Regulation") we would like to inform you about the processing of your personal data by our organisation.

#### **Controller of Personal Data**

# **Purpose of Processing**

The UIACH will process your personal data (name and surname, academic titles, contact details of the workplace: address, telephone, e-mail address, bank details, CV, photographs) solely for the purpose of preparing and realising the international conference CECE 2018 and preparation of the future CECE conferences, including presentations, publishing of yearbooks and taking photographs for news purposes.

The legal basis for the processing of personal data is legitimate interest of the UIACH, in particular development of scientific cooperation and transfer of scientific information.

Personal data will be processed for the duration of the CECE international conferences.

### **Recipients of Personal Data**

Personal data will be processed fairly and in a transparent manner. During processing, automated decision-making, including profiling, will not be used. Appropriate technical and organisational measures will be implemented in accordance with the Regulation.

Personal data will be accessible only to the authorised employees of the UIACH who have the authority to process personal data in the agenda of the scientific conference and other public events organised by the UIACH.

Personal data will not be transferred to third parties. The controller does not intend to transfer personal data to a third country or an international organisation.

# **Rights of Personal Data Provider**

Request from the controller confirmation regarding processing of your personal data; you have the right of access to such data; to rectification of inaccurate or incomplete data; to erasure of your personal data; to data portability or to restriction of personal data processing.
